Explanation of Variances in Section One of the Audit Statement

Box 3: For 2014/15 the only other receipt save for the precept was a refund of VAT. The Parish Council has applied to recover the VAT for 2015/16 but as at 31.03.2016 had not received the same.

Box 6: In 2014/15 there was an extraordinary expense incurred of £1160.00 being the maintenance of trees on The Spinney which is owned by the Parish Council. In addition the Parish Council paid for some road traffic cones in the sum of £29.99 and paid an audit fee of £36.00. In 2015/16 the Parish Council spent the sum of £864.00 in respect of the maintenance of the trees but did not incur an audit fee and did not have any other extraordinary expenses. The insurance premium was approx. £46 less than in 2014/15 and in 2014/15 money was spent renewing the website and acquiring some additional software in the sum of approx. £25.00. In addition the website hosting fees for the last quarter of 2015/2016 had not been paid prior to 31.03.2016.
